

STATEMENT OF SERVICES

PROFESSIONAL SERVICES.....\$560.00
 Non-declinable services of staff includes, but is not limited to: Staff to respond to initial request for service; arrangement and conference with family or responsible party; preparation of necessary authorizations and permits; including coordination with those providing other portions of requirements, i.e. crematory, transportation services. Also included in this charge are overhead expenses, secretarial and administrative costs, and equipment and inventory expenses.

TRANSPORTATION.....\$380.00
 Includes removal from place of death locally. Other areas will be quoted depending on distance. There may be an charge for evening, weekend and holiday removals.

BASIC CREMATION CONTAINER.....\$25.00
 (Sales tax not included) Additional charges will apply for oversize removal and cremation. Cremation container special needs \$150.00 plus tax**

CREMATION AND REFRIGERATION*.....\$380.00
 A few days will elapse from the time of death until cremation is completed. This time span necessitates a refrigerated holding facility, thus eliminating the need and cost of embalming.

DELIVER TO SEA.....\$150.00
 By boat and a memorial certificate stating the day of delivery to sea. (Transport containers are reused for the transportation of cremated remains from the crematory to the delivery at sea and garden scattering.)

OR

GARDEN SCATTER.....\$150.00
 At Evergreen Cemetery

OR

RELEASE TO FAMILY.....\$150.00
 Basic container (sales tax not included). Processing and handling for placement in container. Family picks up remains at our office in San Jose

ADDITIONAL SERVICES

SHIPPING.....\$175.00
 Cremated remains to anywhere in the United States. This Fee includes preparation and postage for registered mailing through the United States Post Office. (The Society assumes no responsibility for accidents occurring during the shipping over which it has no control.)

DELIVERY of cremated remains within a 30 mile radius.....\$130.00

EXPRESS MAIL OF DEATH CERTIFICATES\$35.00

DRESSING includes wash and feature set.....\$425.00

CORONERS FEES.....VARIES
 Each counties coroner's office or medical examiner facility charges a fee if the individual is to be removed from their facility.

California Cremation Society makes every effort to have remains ready in **10 to 12 business days. Certain circumstances, such as the Coroner's Office, government holidays and weekends could alter this time frame and cremation could take longer to accomplish.*

DIRECT CREMATION WITH CONTAINER PROVIDED BY PURCHASER.....\$1320.00
 Our cremation container is the least expensive option for crematory acceptance. You can use an unfinished wood box or other upgrade combustible casket, or you can provide your own container or casket. All such containers must meet crematory requirements.

ALTERNATIVE CREMATION CONTAINER.....price range \$45.00 - \$150

SPECIAL HANDLING AND CIRCUMSTANCES

Additional charges will apply for oversize removals and cremations depending on number of removal people, container, vehicle and other situations that can only be determined at time of need.

**SPECIAL NEEDS CONTAINER

For remains with height and weight that exceeds the capacity of the basic container.
